Our mission is to stand with and support adults, majority women, with experience in the commercial sex trade and its associated exploitation, trafficking and prostitution, by providing a range of communitybased services.



Working Towards Wholeness and Healing

RIA builds healing relationships to support adults, majority female, identified with experience in commercial sex. RIA accompanies participants where they are in their lives, whether experiencing homelessness, living in a shelter, or in a more stable housing situation. Exploitation robs people of their born identities, it diminishes self-esteem, and hurts physically and emotionally. RIA walks with people as they feel value and joy and are seen and loved.





Measuring Our Impact:

Each encounter encompasses multiple personal interactions between participant and staff. Individual interactions are categorized and logged by mode of communication to reflect engagement time.

What does group support look like at RIA?

RIA offers three weekly support groups: one in Worcester, one in Framingham, and one on a virtual platform. Groups are led by RIA's Peer Mentorship Team. The following quotes from participants offer insight into the sense of community and belonging fostered by these support groups.


WHow has RIA's virtual support group affected your life?

^{••}Ever since I started my journey with RIA back in 2022 and attended the Gala, I've been amazed at how much I've learnt and have grown over the course of my experience with RIA. I look forward to growing more in many areas necessary for my restoration towards the opposite sex. I must admit at the beginning of this journey to heal from my sex trafficking experiences, I didn't think the Tuesday meetings were worth my time. After, consistently attending them with you, I've learned quite a bit of wisdom, additional positive thinking strategies, new ways and ideas to address difficult situations especially centered around relationships, a deeper understanding of healthy boundary setting and I've gained further insight on how important it is to have a safe space for women to talk and have meaningful discussions regarding our unfortunate past sexual assaults, together as a whole.⁹⁹



What is Survivor-Directed Housing?

RIA's rental assistance program provides crucial support to enrolled participants for anywhere from 6 to 24 months and offers practical aid in their journey toward stability and independence. By increasing access to safe housing, the program enables individuals to break free from the cycle of exploitation and begin rebuilding their lives with dignity. With the burden of rent alleviated, participants can focus on healing and accessing necessary resources, gradually reclaiming control over their futures. Since March 2022, RIA has enrolled 10 participants in this program.



Survivor-Directed Housing Outcomes

The following participant outcomes were assessed after at least six months of rental assistance and support





Only 25% of participants reported having extremely high financial stress



63% of participants reported being in a healthy relationship



One participant regained full custody of her child





In Conversation with NICK JOSEY

Nicholas Josey is the Executive Director of The Vincita Institute and collaborates with RIA by providing monthly financial coaching for participants enrolled in the Survivor-Directed Housing Program.

[•] I left the financial services industry in order to have a greater and more positive impact in the life of others. I started a nonprofit organization: The Vincita Institute, in order to educate and help more people to make better informed financial decisions that should positively impact all individuals and their families.⁹⁹

Con How does what you do impact our participants (in your words-the goal)?

Nick: When we began the program, I didn't have a definitive plan as I was only hopeful to be able to have some form of a positive impact with each of the group participants. My goal at the time was to learn how to share the Vincita motto; to engage, educate and empower each and every woman in the RIA program.

How has the work with RIA impacted you?

Nick: Thus far this has been a fascinating journey. I have been truly amazed by the amount of love, support and commitment that the RIA team members have bought to each session designed to impart valuable financial education concepts. This is truly a wonderful and personally impactful team effort. I look forward to every opportunity to connect each month to find different ways to uplift and motivate the participants. I have admitted during at least one of our group chats that I have three beautiful yet imperfect daughters whom I love with all my heart. It is comforting to know that an organization like RIA exists, should any of my children stumble or fall. I see the sincere desire of the RIA women to become victorious in spite of potential daily challenges. I am so thankful to have an opportunity to simply share, and to perhaps make a positive difference during each group video chat.

What is the future of Nick & RIA?

Nick: I sincerely look forward to maintaining a great relationship with RIA as I think that we share a similar synergistic energy designed to uplift and encourage every program participant to fearlessly reach their greatest level of growth and potential, one step at a time.

In the journey...there is life changing impact

After leaving Cuba, **Joya's*** mother married a man she barely knew. Joya's stepfather made her do things that she hated and by 14 years old, she left home, believing she would be better off on the streets. After weeks of couch surfing, Joya was befriended by an older man who groomed her into commercial sex, exploiting her body for profit. For the next 20 years, Joya faced homelessness, violence, sexual abuse, addiction, and prison. Through a weekly support group, she met a **RIA Mentor** who got to know her better, building trust to begin one-on-one support.

Today, Joya is beginning to see a new life for herself. She recently enrolled in college to pursue a bachelor's degree with the help of RIA's **SheFund**. With new awareness and support from RIA, Joya continues her healing journey and dreams of someday being a nurse.



*RIA operates on a cash basis accounting system rather than an accrual basis. The apparent deficit stemmed from the non-renewal of one of our three major federal grants—a highly competitive award that we were fortunate to have originally secured. Although we were previously one of 33 grantees nationwide, the grant was awarded to other organizations in 2023. To mitigate this loss, we pursued alternative funding avenues, securing additional foundation grants and launching targeted fundraising campaigns to sustain our operations. Additionally, we received several foundation grants towards the end of 2022, spanning into 2023, which were deposited into our account during the third and fourth quarters of 2022 to support expenses throughout the subsequent year.
