

# SUMMARY

In 2024, RIA served 103 survivors of commercial sexual exploitation and sex trafficking through over 5,800 one-on-one service care encounters and over 8,000 staff with participant interactions. RIA’s highly trained staff provided comprehensive services to support survivor safety & basic needs, mental health & well-being, housing stability, and economic empowerment.

Word continues to spread about RIA’s unique service model that is centered on trust and building long-lasting relationships:

**46** new survivors came to RIA in 2024 seeking support.

As RIA’s reach grows, we are building our staff team and investing in services that support long-term well-being, independence, and empowerment among the women we walk alongside.





## Participant Age




## Race/Ethnicity



## Sexual Orientation





NUMBER OF PARTICIPANTS ENGAGED IN EACH RIA SERVICE





# Survivor Basic Needs & Safety




With complex trafficking experiences and multi-victimizations, our ability to meet basic needs is critical for establishing safety and distance from exploiters.

# \$12,805

*was distributed by RIA in 2024 for basic needs to 65 survivors.*

In addition to financial assistance, RIA provided:

- **1,396 case management** encounters
- **925 referral** encounters
- **140 crisis intervention** encounters

## Extreme financial stress substantially decreases among RIA participants

**67%**

of survivors coming to RIA in 2024 reported extreme financial stress at intake

**29%**

of all RIA participants had extreme financial stress as of November Assessment

## AMONG RIA PARTICIPANTS IN NOVEMBER 2024:

*were out of the sex trade\**

*\*73% of participants are completely out, 15% mostly out, and 6% half out*

*were safely housed*



# Mental Health & Well-Being

of survivors reported past **suicidal attempt or ideation**





# Housing & Stability

Housing is a major challenge for survivors



## Monthly rental assistance prevents re-trafficking and enables long-term recovery

In 2024, RIA provided housing services to 57 survivors, including:

- **363** relocation support encounters
- **112** transitional housing assistance
- **83** shelter placements
- **75** total months of rental assistance

**\$76,093**

was distributed by RIA in 2024 for survivor housing and rental assistance.



14 survivors received rental assistance in 2024, with 11 getting between 6-12 months.



# RIA prioritizes establishing safe, stable housing



## Survivor Voices

# Economic Empowerment

Education & employment are critical for long-term recovery and empowerment.

## RIA helps survivors obtain and hold jobs

## RIA helps stabilize and increase survivors' income



Average financial stress at intake is **8 out of 10**



Average financial stress reduces to **6 out of 10**

## In 2024, RIA provided:

- **492** legal & justice support encounters to **57** survivors
- **479** personal advocacy encounters to **54** survivors

## LIFE EVENTS

The most common positive life events related to education & employment for RIA participants in 2024 were:

- *Maintaining & getting a new job*
- *Progressing in education*  
(e.g., enrolling, graduating)
- *Being motivated to pursue education or being happy working in their job*

## Updates from Mentors

*"She graduated from undergraduate and got a job!"*

*"She has maintained full-time employment for two years."*

*"She was able to go full-time at her job and is taking classes at a university."*

- **122** employment support encounters to **30** survivors
- **618** financial aid for basic needs encounters to **65** survivors




## Survivors stay engaged in RIA's high quality services

LENGTH OF ENGAGEMENT IN RIA AMONG 2024 PARTICIPANTS (N=103)





# HOW *ria* COLLECTS & ANALYZES DATA

COLLECT DATA

## INTAKE DATA

When an adult first comes to RIA, our intake collects information on demographics, victimizations, service needs and immediate goals.

## SERVICE ENCOUNTER DATA

Throughout the year, RIA staff enter information on what services they provide to survivors, as well as mode of interaction (phone, text, in-person, etc.)

## SURVIVOR OUTCOME DATA

Every 6 months, staff complete a Life Events Assessment for participants actively engaged in services. RIA developed this assessment with funding from the U.S. Department of Justice and in collaboration with faculty at Harvard Medical School. It collects information on housing, education, employment, financial stress, relationships, substance use, and distance from the sex trade.



## TRACK & ANALYZE

We regularly track data via an Impact Dashboard that reports and visualizes important metrics.

Every 6 months we partner with a PhD-level researcher to conduct a deep dive analysis, including thematic analysis of qualitative outcomes, longitudinal analyses, and more to gain a better understanding of our participants and programs.



## DISCUSS, DISSEMINATE, AND IMPROVE

Together our staff reviews the data, identifies challenging areas, and discusses how we can improve our services to better meet the needs of survivors in our region.

We share results with funders & community partners to increase knowledge and awareness.
